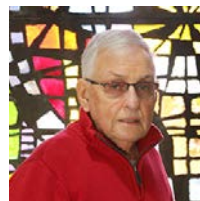

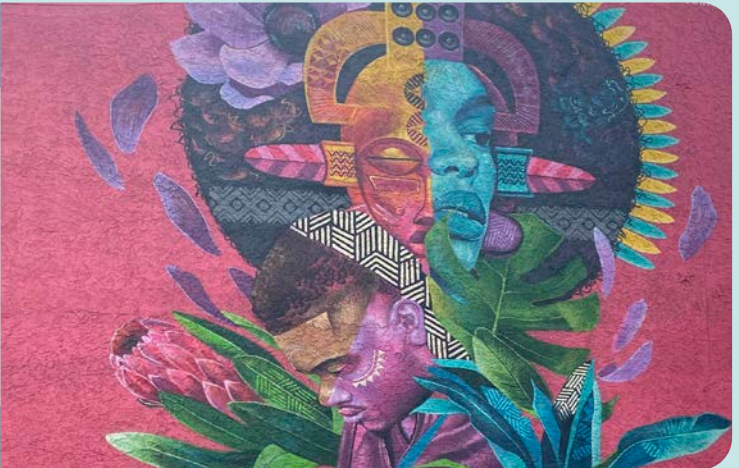

Over the past decade the Lehigh Valley Community Foundation has experienced tremendous growth. We have cultivated new philanthropic partners; increased the quantity and, more importantly, quality of relationships in the nonprofit sector; and expanded the size and expertise of its staff. Hand-in-hand with this growth is our increased visibility, credibility, and influence. Donors, nonprofit leaders, community leaders, and others now look to us for insight, involvement, and resources. We have developed a trusted and valued voice, which should be celebrated and amplified.

This strategic plan uses our voice to further establish the Community Foundation as a trusted advisor, partner, and community leader. We are in the midst of a pandemic and a renewed social justice movement. Community foundations across the nation are embracing leadership roles in their communities and speaking more intensely about the role of equity. These shifts could be considered threats to a traditional business model. In this strategic plan we are embracing this evolving landscape to create opportunities for the Foundation to continue its growth.

We look forward to sharing the results of our work, which will not stop in 2025, but rather move to a deeper level of commitment, influence, and partnership.

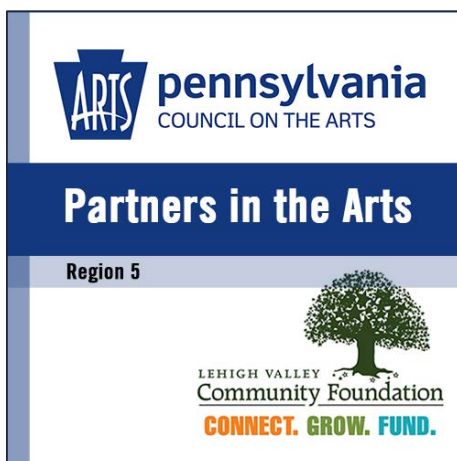
# The Power of Partnership in the Arts

## LVCF Named Regional Partner Agency of the Pennsylvania Council on the Arts

In October of 2021, Lehigh Valley Community Foundation announced it was named as a regional partner agency of the Pennsylvania Council on the Arts (PCA). Through the Pennsylvania Partners in the Arts program (PPA), LVCF will work with the Pennsylvania Council on the Arts to distribute grant awards for projects or programs involving artists throughout Region 5, which includes: Carbon, Monroe, Lehigh and Northampton counties. This program enables the Pennsylvania Council on the Arts to reach a wider audience by increasing access to funds for organizations and artists across the state, thereby increasing statewide audience exposure to arts activities.

“The Lehigh Valley is home to a vibrant and growing creative sector, making the region a great place for residents and visitors alike,” said **Karl Blischke**, Executive Director of the PCA. “We are pleased to work



with LVCF, through our PA Partners in the Arts re-granting program, to further strengthen quality of life in the Lehigh Valley through grant opportunities to the region’s many engaging arts organizations and programs.”

“The Community Foundation is pleased to be selected as this region’s PCA partner. We look forward to assisting in achieving the PCA’s goal to promote equitable access for all Pennsylvanians to participate fully in a creative life

and in the diverse forms of arts and culture in the commonwealth,” said **Megan Briggs**, Director of Community Investments, Lehigh Valley Community Foundation.

Pennsylvania Partners in the Arts grants during 2021-22 were divided into three categories:

- 1) **Program Stream**
- 2) **Entry to Program Stream**
- 3) **Creative Entrepreneur Accelerator Program**

**Program Stream** is an invitation-only grant opportunity which offers ongoing support to arts organizations and arts programs with an established history of funding from the Pennsylvania Council on the Arts. Once admitted to this funding stream, organizations receive consistent general operating support for arts programming.

Entry to Program Stream is a new funding opportunity that aims to provide valuable access to funding



for small arts organizations and programs across the commonwealth. *Note that the program is being replaced by PCA in 2023.*

**Entry to Program Stream** offers a new pathway for small arts organizations and programs across the commonwealth to receive ongoing, unrestricted general operating funds. *This program is also being replaced in 2023.* Learn more about these programs during 2021-22 in the grants section of this report (page 37).

The **Creative Entrepreneur Accelerator Program** is designed to pair access to existing small business consulting services with financial resources for creative entrepreneurs who aspire to start their own for-profit business or who operate an existing for-profit micro business. The Program's purpose is to help creative entrepreneurs to grow their business, audience, and revenue. The opportunity to apply for the Creative Entrepreneur Accelerator Program was launched in Winter 2021. The funding process will operate on a rolling basis until funds are expended.

### About the Pennsylvania Partners in the Arts (PPA) Funding

This project was supported by the Pennsylvania Council on the Arts, a state agency, through the Pennsylvania Partners in the Arts (PPA), its regional arts funding Partnership (Lehigh Valley Community Foundation – Region 5). State government funding comes through an annual appropriation by Pennsylvania's General Assembly and from the National Endowment for the Arts, a federal agency. ## NEW FOR 2023-24 Creative Sector Flex Fund

The Pennsylvania Council on the Arts (PCA) is excited to introduce a new grant program, the Creative Sector Flex Fund (CSFF), for the 2023-2024 grant year. The CSFF is designed to address the changing needs of dynamic PA arts organizations with average annual revenue between \$10,000 – \$200,000.

This grant program incorporates the current needs of the field by offering grantees the flexibility to use \$5,000 grants in ways that ensure the most significant impact for their organizations and communities. Eligible uses of funds are flexible, including the support of applicants' administrative, programmatic, and project-related expenses.

It was a welcomed return to in-person interactions and the energy created when over 60 people gather for good conversation and good company. **Erika Riddle Petrozelli**, LVCF President and CEO, provided an update on the Community Foundation's new strategic plan titled "Growth Through Partnership," which will be released to the public this summer and discussed in more depth in our next issue.

Erika introduced one of the primary strategic initiatives, "Nurturing Place-Based Philanthropy," as it relates to the keynote presentation: The Great Wealth Transfer.

**R. Nicholas Nanovic, Esq.**, Partner and Chair of Trusts & Estates, Gross McGinley, LLP, and a member of LVCF's Board of Governors, presented The Great Wealth Transfer topic – what it means and the implications for philanthropy.

As the Lehigh Valley region experiences growth, both economically and culturally, the Foundation is developing thoughtful philanthropic solutions for families and businesses who want to make a bigger impact. She explained how LVCF's new EverGreen Fund is designed as an alternative to a private foundation, with built-in support by way of LVCF resources, expertise, and community knowledge. The Community Foundation acts as paid staff to keep the fund on track and impactful, easing the burden and workload that a private foundation would require.

organization that is led and staffed by neighborhood residents in Allentown, Pennsylvania. PNLV comprises a unique network whose role in our community is to promote consistent public health messaging, delivered by trusted community messengers. The mission of PNLV is to foster

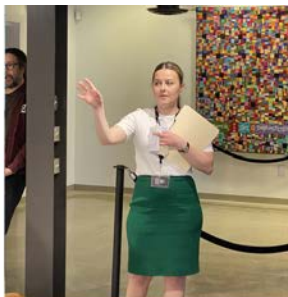

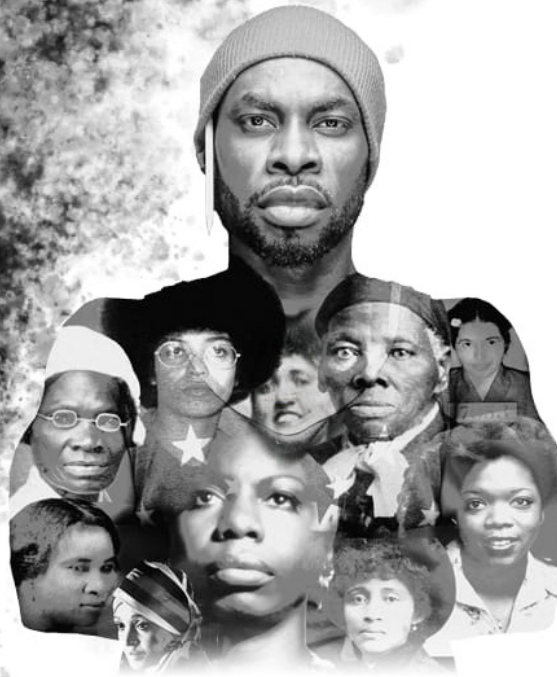

"When we saw the Heroes collection and learned more about Bart Cooper's efforts to engage and educate the community about the impactful roles powerful Black women have played throughout history—we were eager to help make it a success," said **Erika Riddle Petrozelli**, President and CEO of the Community Foundation. "We are so pleased that Faces International, in partnership with ArtsQuest and the United Way of the Greater Lehigh Valley were

able to bring an exhibit that is so creative and powerful to our area. Bart Cooper's ability to generate conversations on social justice and equity by applying the lens of popular culture to illustrate the strength and resilience of these women is a 'superpower' onto itself—we couldn't be more impressed by this work."

Through his work, Cooper strategically intertwines the real with the fictitious characters of modern-day heroism through the contemporary use of mixed media to create portraits of powerful black women, matching them to suitable Marvel characters to highlight the connection between America's favorite comic characters,





and the country's history of brave and important Black women leaders. "Their intelligence, their trials and tribulations, their willingness to lead shows strength and resilience. These people had powers and practiced them rigorously, and not only for themselves, but for others," says the artist, **Bart Cooper**.



The Heroes Exhibition was held during the spring of 2022 at the Banana Factory was free and open to the public. ## Reinventing Our Communities (ROC) Cohort Program

### **LVCf Convenes Allentown Cohort for the Federal Reserve's "Reinventing our Communities" Program**

In the fall of 2021, LVCf and eight partner organizations participated in the Philadelphia Federal Reserve's Reinventing Our Communities (ROC) 2021 Cohort Program to strengthen the local economy by helping Allentown address structural racism and barriers to opportunity in the small business sector.

The ROC Cohort Program was a ten-month in-depth racial equity capacity building program for cross-sector community cohorts. The Allentown cohort will engage in equity training, community and economic development webinars, technical assistance, and a community of practice, leading to the development of an equity plan for addressing the challenge through the development of local solutions.

The Allentown cohort is a group of cross-sector community leaders who participated in workshops and peer learning that allowed them to gain skills and create a tailored racial equity plan to address local challenges. The Community Foundation's **Megan Briggs**, Director of Community Investments served as the cohort lead. "What is unique about our group is it's cross-sector involvement," she noted. "Our group includes not only sector professionals, but also the voices of small business owners who understand the need and can help us move forward with a plan that can make a real difference in the community."

Lehigh Valley Community Foundation is partnering with the City of Allentown, Community Action Development Corp. of Allentown, Lehigh Valley Planning Commission, Greater Lehigh Valley Chamber of Commerce, The Rising Tide Fund, Martindale Center for the Study of Private Enterprise at Lehigh University and two Allentown small businesses – Visit Vans and Straight A Uniforms.

The Federal Reserve provided equity training for the Allentown cohort along with economic development training on best practices, followed by technical assistance specially tailored for Allentown and surrounding region. [More...](#)

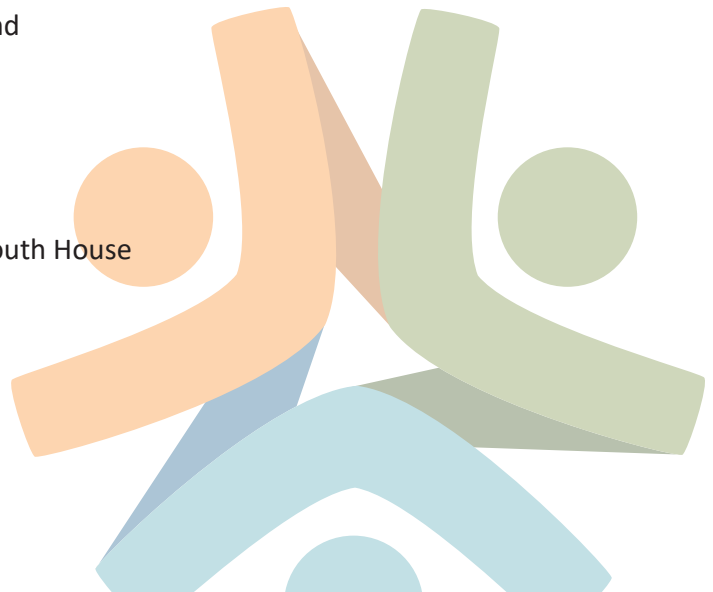

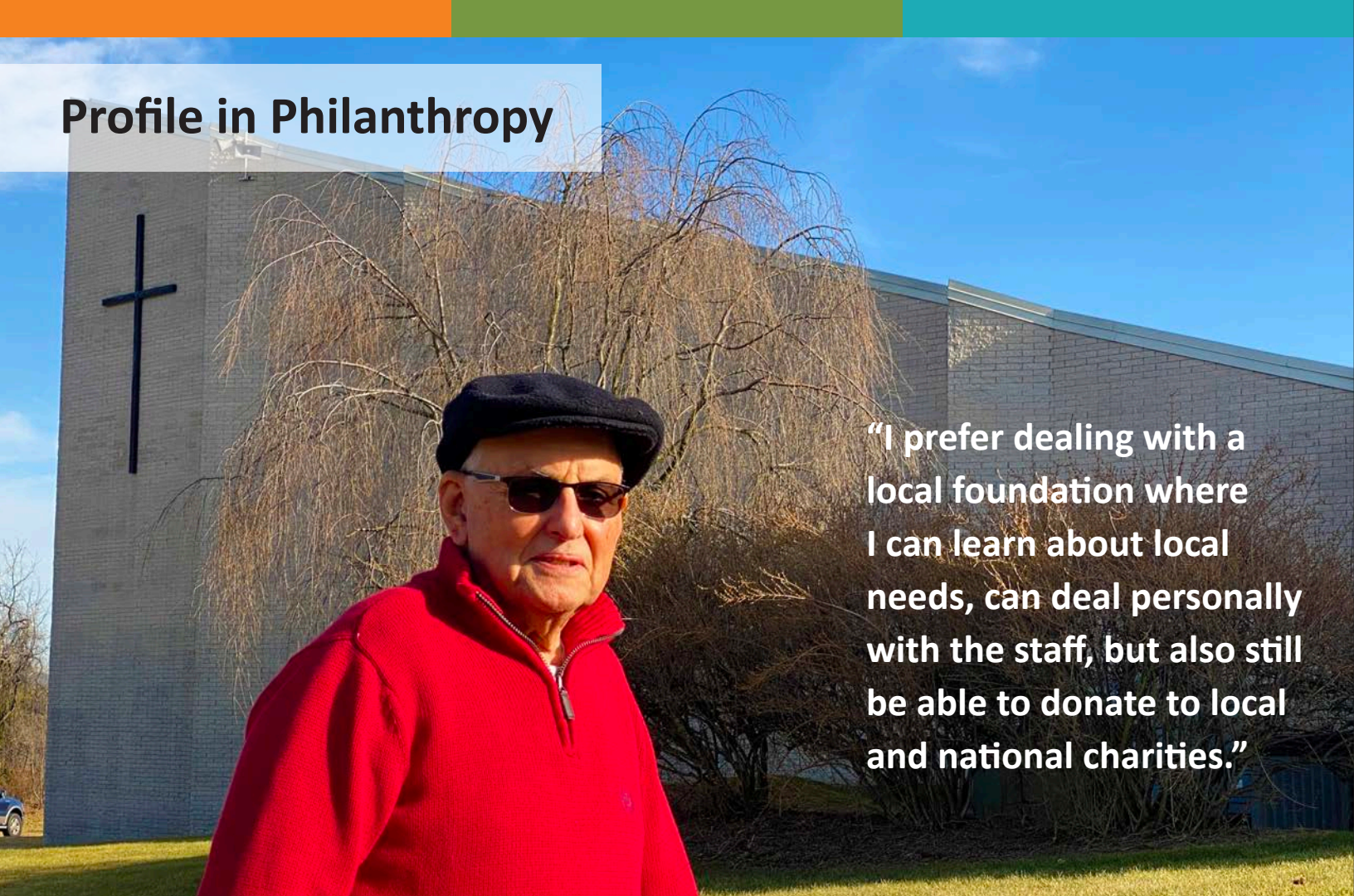

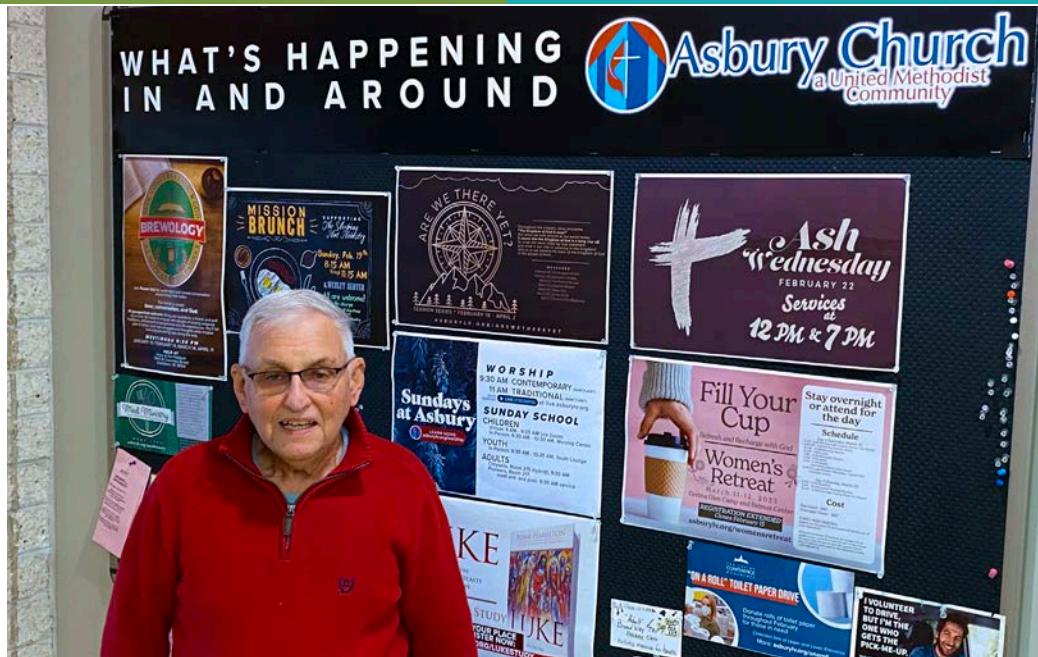

## LVCF Renews Capacity Building Grants for BIPOC-led Nonprofits

Lehigh Valley Community Foundation renewed Nonprofit Effectiveness grants for the 2021-22 funding cycle. Eight Lehigh Valley nonprofits that participated in the Foundation's capacity building program during the 2020-2021 grant cycle were awarded grants to continue as a cohort. This cohort of organizations is specifically designed for organizations whose leadership identifies as being Black, Brown, Latinx/o/a, or Asian, and are committed to serving Lehigh Valley's Black and Brown communities.

LVCF initiated this grant opportunity in recognition of the valuable role that diverse organizations have in providing culturally-centered approaches in delivery of services and programs to the Lehigh Valley community. In addition to a \$14,000 grant that each organization received in the first year of the program, each of the following organizations received a \$10,000 grant for general operating expenses and participated in the Community of Practice:

"Continued funding for organizational capacity building is necessary to ensure the long-term sustainability of these important organizations," said **Megan Briggs**, LVCF Director of Community Investments. "We are so pleased to be partnering with this truly powerful group of nonprofits again to build upon the momentum we achieved together in the first year of the program."

The Foundation launched the Nonprofit Effectiveness Program as a pilot in 2018 to provide targeted internal infrastructure support to assist in strengthening nonprofit effectiveness in a variety of ways. The model included not only grant funding for a capacity-building project, but also offered grantees a Community of Practice, a space for individual reflection in community and deepening relationships with peers.

Leaders in the Community of Practice Program worked in sessions and in a practicum to build collective agency that models the principle of abundance and the power of cooperation. These sessions were facilitated by **Joyce Johnson Shabazz** and **Phyllis Alexander**, both who are nationally-recognized consultants in the field of racism, equity and inclusion.

Phyllis Alexander will continued to work with the 2021-2022 cohort to create a space to continue authentic connections. One of the sessions include **Hannah Hasan**, an award-winning, highly acclaimed spoken word poet, speaker, and storyteller who worked with the cohort to craft and tell their own stories.

## LVCF Grants Support Nonprofits Serving Youth and Families

Lehigh Valley Community Foundation granted more than \$185,000 in general operating grants to area nonprofits serving youth and families as part of its foundation-directed community investments grantmaking in FY22.

The Community Foundation manages several different area-of-interest funds that are focused on supporting Lehigh Valley youth and families, including The Edward & Inez Donley Fund; Walter & Alma Bastian Fund; Outdoor Recreation Fund for Youth; Robert D. & Gwendolyn-Jane Romeril Campership Fund; Lucille F. Driver Fund, and support from Roger and Kathy Yott.

“The Community Foundation’s goal in awarding these grants is to offer flexible funding to organizations that provide comprehensive approaches in engaging youth and their families in seeking a pathway for meaningful life aspirations,” explained **Megan Briggs**, LVCF’s Director of Community Investments. “Guided by the communities they serve, these organizations prioritize either mental health needs in young people or focus on youth leadership development.”

The grants applications were evaluated by the Youth & Families Advisory Grant Committee which included both content and context experts in the field of youth and families. The committee representatives included several diverse perspectives including age, geography, race, ethnicity, income, and gender. Applications were evaluated based on the organization’s area of focus, the population they serve, and how they are guided by the community in proving transformational youth services in an equitable manner.

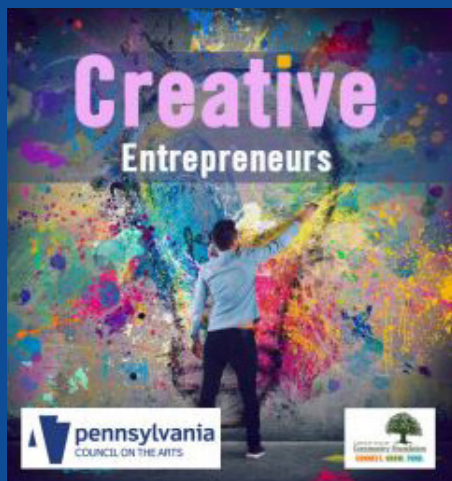


# LVCF Issues PPA Project Stream and CEAP Grants in 2021-22

Lehigh Valley Community Foundation issued grants during 2021-22 through the Partners in the Arts program (PPA) in conjunction with the Pennsylvania Council on the Arts. LVCF issued \$78,000 in grants to 26 organizations for Program Stream, an invitation-only grant opportunity which provides ongoing support to arts organizations and arts programs with an established history of funding from the Pennsylvania Council on the Arts.

LVCF also launched the Creative Entrepreneur Accelerator Program (CEAP) in 2021-22 which matches eligible creative entrepreneurs with existing, free, local, small business consulting services and financial resources up to \$2,000 to help them grow their businesses, audiences, and revenue. CEAP is designed to prioritize investments in socially or economically disadvantaged creative entrepreneurs and those who are located in and whose work benefits low-income

communities, as defined by the Small Business Administration. Applications to the Program were accepted on a rolling basis. During FY22, \$62,000 in grants went to 31 creative entrepreneurs in Region 5.



"We are pleased to be able to grant this funding to small local businesses that enhance our community through the arts and creative services," said Monique Moreno, LVCF Grants Associate. "We are helping creative entrepreneurs grow their business, audience, and revenue while

advancing Pennsylvania Council on the Arts and the Community Foundation's overarching value of diversity, equity, and inclusion."

LVCF is the regional partner agency of the Pennsylvania Council on the Arts. Through the Partners in the Arts program (PPA), LVCF works with the Pennsylvania Council on the Arts to distribute grant awards for projects or programs involving artists throughout Region 5, which includes: Carbon, Monroe, Lehigh and Northampton counties.

"We are so pleased to be the Pennsylvania Region 5 Partner in the Arts for the program," said **Megan Briggs**, Director of Community Investments at the Community Foundation. "Creative entrepreneurs are the engine that drives new economic development in the Arts, Culture, and Creative Economy, bringing both meaningful jobs and valuable creative services to the community. With these grants, we hope to support often under-invested in creative entrepreneurs in our region."



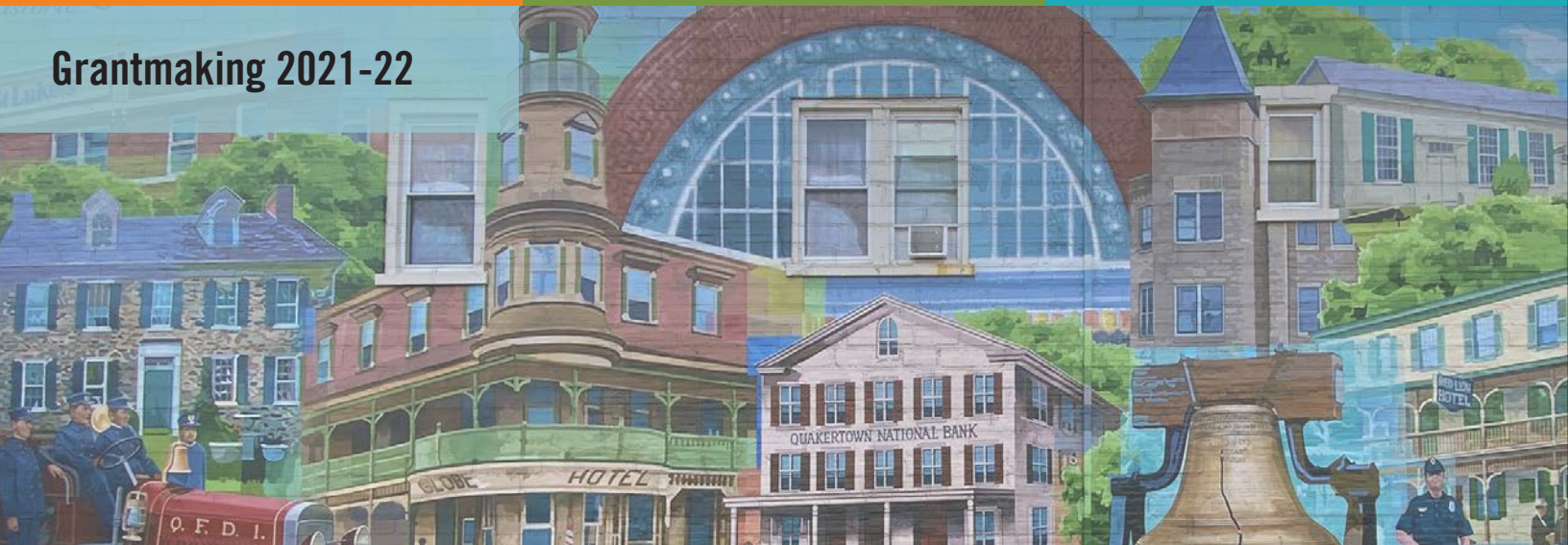

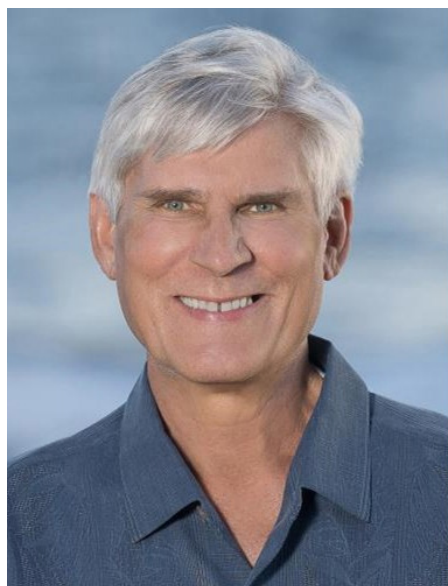


### New Scholarship Fund at LVCF Honors the Memory of Andrew Budraitis

In March of 2022, LVCF welcomed the establishment of the Andrew Budraitis Foundation Scholarship that awards two \$7,500 scholarships annually to recipients majoring in a STEM (Science, Technology, Engineering, or Math) field and attending a college in the greater Lehigh Valley Area. The scholarships support one Lehigh Valley veteran and one non-veteran, both with priority given to those with financial need.

The scholarship was established in memory of **Andrew Budraitis**, a lifelong resident of the Lehigh Valley, and is intended to pay tribute to him and remember his life. "When we lost my dad last November, I wanted to be a part of something that would honor him and pay tribute to the life he lived," explained **Brian Budraitis**. "We all thought what better way to do that than to start the Andrew Budraitis Foundation Scholarship. I'm grateful for our partnership with the Lehigh Valley Community Foundation and all of the help they have provided us along the way."

Andrew served in the United States Army, 82nd Airborne Division until 1981. After being honorably discharged at the end of his term,



he worked temporarily at a sod farm before eventually being hired by Air Products and Chemicals. While there, he took night classes at Muhlenberg College, earning his bachelor's degree within 9 years. His hard work and dedication paid off. He excelled within his career at

Air Products, leading to global, senior Director positions within Information Technology.

"My husband Andy was an incredible leader and mentor to others—and a veteran," explained **Alyssa Budraitis**. "I saw first-hand, the careers he greatly helped and supported throughout his career in the STEM field. As a non-traditional student, it took him many years at night to get his college education. He valued and encouraged others to get their degree as well."

"Our family grew up in the Lehigh Valley and spent our lives here. In working with the Lehigh Valley Community Foundation and creating a foundation in Andy's name, it enables us to honor him and give back to our local community and our veterans in a way that is important to us." Established in 1967 as the Bethlehem Area Foundation, the Foundation was regionalized and re-named in 1992 in order to serve the entire Lehigh Valley. Today, the Foundation manages more than 290 charitable funds representing \$75 million in assets.
