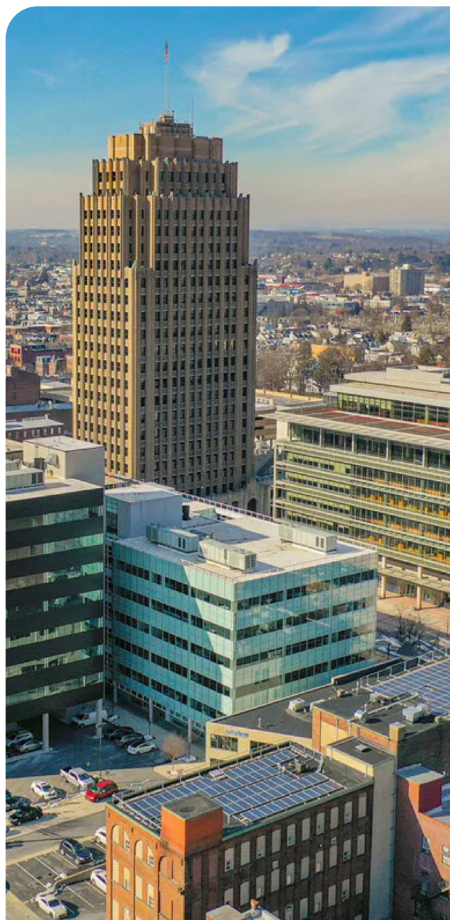

## Message from the Board Chair & President and CEO

At the Lehigh Valley Community Foundation, our work is rooted in a simple but powerful belief: when we invest in our community, we strengthen the systems, people, and partnerships that allow our region to thrive. As we reflect on the fiscal year ended June 30, 2025, we do so with deep gratitude for the donors, nonprofits, civic partners, and leaders who make this mission possible.

This year marked a transformative period in our Foundation's history. We closed the fiscal year with over \$100 million in charitable assets under management, a significant milestone for community foundations that reflects both the generosity of our donors and the trust they place in our stewardship. In this fiscal year, the Foundation received more than \$22 million in gifts and distributed over \$9 million in grants, both of which are significant figures. We stand firmly in our role as a community leader helping nonprofits deliver essential services and advance meaningful change across the Lehigh Valley.

In particular, we continued to spotlight the importance of early childhood education and to address the challenges that parents face to access affordable,

quality childcare. We have deployed innovative approaches to addressing this urgent local need, such as our first impact investment to support the expansion of a childcare facility in downtown Allentown. These investments, paired with our engagement in regional efforts such as the Early Childhood Education Collaborative, demonstrate how strategic partnerships can expand opportunity for families and children.

Internally, we strengthened the organizational infrastructure that enables our mission. With a new accounting system and donor portal, expanded visibility efforts, and continued investment in our staff, LVCF is poised for the next phase of growth. As we prepare to develop a new strategic plan, we do so with a renewed focus on impact beyond the check, growth through partnership, and our values of Connection, Opportunity, Integrity, and Learning.

We extend our heartfelt thanks to all who contributed to this year's accomplishments. Together, we are investing in community—today, tomorrow, and for generations to come.

# Strengthening Early Childhood Education in the Lehigh Valley

For families across the Lehigh Valley, access to high-quality, affordable childcare is essential — not only for children’s development, but for parents’ ability to work, employers’ ability to hire, and the region’s long-term economic health. Yet early childhood systems remain under strain, challenged by workforce shortages, rising costs, and uneven access.

The Lehigh Valley Community Foundation has responded by deepening its commitment to early childhood education as a core strategy for strengthening youth, families, and the broader community. In Fiscal Year 2025, the Foundation continued to evolve from a traditional grantmaker into a regional leader — aligning funding, convening partners, and advancing systems-level solutions that support children and those who care for them.

## Leading Through Collaboration

At the center of this work is LVCF’s role as the backbone convener of the [Early Childhood Education Collaborative](#) (ECEC), a cross-sector partnership of nonprofit organizations, educators, funders, government agencies, and business leaders working together to address the region’s childcare challenges.

As convener, LVCF provides the infrastructure that allows partners to move beyond isolated efforts toward coordinated action. We facilitate shared strategy, support collective learning, and elevate early childhood as a regional priority—ensuring that voices from across sectors are aligned around common goals.

This collaborative leadership was on full display during the 2025 Week of the Young Child, held April 5–11. The week-long celebration brought together families, educators, and community partners to highlight the importance of early learning and to recognize the professionals who make it possible. Events included a virtual kick-off, an Early Childhood Educator Appreciation Dinner, creative artist-in-residence programming at community sites, and a space transformation project designed to promote early literacy and learning through everyday environments.



A coordinated social media campaign amplified these efforts, reaching thousands of residents across the Lehigh Valley. More than \$35,000 was raised through sponsorships, demonstrating broad community support and reinforcing early childhood education as a shared civic responsibility.

## Statewide Advocacy

LVCF's early childhood work is informed not only by local needs, but also by statewide learning and advocacy. Through active engagement with Pennsylvania Association of Community Foundations and broader early childhood coalitions in Pa., LVCF helps ensure that regional strategies are aligned with state policy priorities.

## Integrating Childcare and Workforce Development

LVCF also continues to advance early childhood education as a workforce issue. As a key partner in Allentown Works, a federally funded economic development initiative, the Foundation leads the childcare component — ensuring that access to reliable, quality care is embedded into workforce planning and implementation. Through collaboration with city leaders and national partners, LVCF has helped design strategies that expand childcare access, strengthen the early educator pipeline, and reduce barriers for parents pursuing employment or training. This work reflects a growing recognition that economic mobility and childcare availability are deeply interconnected — and that solutions must address both simultaneously.

## Strategic Grantmaking for Youth and Families

While leadership and convening are critical, grantmaking remains a cornerstone of LVCF's impact. In FY2025, the Foundation awarded more than \$175,000 through its [Youth & Families grants program](#), supporting organizations that advance early learning, strengthen families, and promote child well-being across Lehigh and Northampton counties. Our long-term approach requires sustained leadership, trusted partnerships, and a willingness to evolve as needs and opportunities emerge.

## A Long-Term Commitment to Children and Families

The progress achieved in FY2025 builds on several years of intentional focus. Since 2022, LVCF has steadily refined its Youth and Families strategy—consolidating grant resources, launching early childhood-specific funding, issuing its first multi-year grants, and investing in dedicated staff capacity to lead this work.

That long-term approach reflects a clear understanding: meaningful change in early childhood systems does not happen in a single grant cycle. It requires sustained leadership, trusted partnerships, and a willingness to evolve as needs and opportunities emerge.

Looking ahead, LVCF remains committed to expanding workforce pipeline initiatives, supporting professional development for early learning staff, continuing community-wide engagement efforts, and strengthening partnerships locally and statewide. Through these efforts, the Foundation is helping ensure that every child in the Lehigh Valley has the opportunity to learn, grow, and thrive—and that families and educators are supported.

By investing in early childhood today, LVCF is laying the groundwork for a stronger, more equitable Lehigh Valley tomorrow.





# Strengthening Leaders Across the Lehigh Valley

Strong communities depend on strong leadership. Across the Lehigh Valley, nonprofit organizations are navigating increasing demands—from shifting funding environments and workforce pressures to growing community needs that require collaboration, adaptability, and long-term thinking. In response, the Lehigh Valley Community Foundation has made leadership development and organizational capacity a central part of its community investment strategy.

One of the most significant expressions of this commitment is the CORE Fellowship, a multi-year initiative designed to support nonprofit and community leaders as they strengthen their organizations, deepen collaboration, and build the skills needed to lead through complexity. Since its launch in 2022, the CORE Fellowship has helped shape how leadership is cultivated and supported across the region, reinforcing LVCF's belief that investing in people is essential to lasting community impact.

## Fellowship Designed for Real-World Leadership

The CORE Fellowship was intentionally designed to reflect the realities nonprofit leaders face. Fellows come from a wide range of organizations and sectors, including nonprofits, local government, higher education, philanthropy, and business. This diversity creates a learning environment where participants gain insight beyond their own organizations and build relationships that strengthen the broader nonprofit ecosystem.

Across three cohorts, the fellowship has engaged 61 leaders from 39 organizations, creating a regional network grounded in shared learning and mutual support. Each participating organization received a \$25,000 grant to support their

participation and capacity building projects, resulting in nearly \$1.2 million invested in strengthening organizations and leadership across the Lehigh Valley. While the fellowship includes facilitated learning, individual coaching, peer exchange, and organizational assessment, its impact extends beyond the program structure. CORE creates space for leaders to step back from day-to-day demands, reflect on their leadership approach, and build practical skills that can be applied immediately within their organizations.

## From Individual Growth to Organizational Strength

Participants consistently describe CORE as a transformative professional experience. Fellows report greater confidence in decision-making, improved communication skills, and a stronger ability to navigate complex organizational and community dynamics. These gains translate directly into organizational benefits, as leaders apply new perspectives and tools to strengthen governance, operations, and service delivery.

The fellowship also fosters collaboration across organizations that might not otherwise work together. By building trust and relationships among leaders, CORE has helped reduce silos and encouraged partnerships that extend well beyond the fellowship itself. Over time, these connections have contributed to more coordinated approaches to shared challenges across the region. CORE's influence is not limited to individual leaders. Organizations participating in the fellowship have implemented changes



that affect staff, volunteers, and the communities they serve—creating ripple effects that strengthen the nonprofit sector as a whole.

## Cohort Three: Building on Momentum

In Fiscal Year 2025, CORE Fellowship Cohort Three entered its second year of programming with a focus on continued growth and application. Fellows worked closely with consultants to identify opportunities for organizational development while designing and implementing capacity-building projects supported by CORE funding.

These projects reflect the varied missions of participating organizations and their commitment to serving the community more effectively. Initiatives range from expanding access to programs and services and to developing new engagement strategies, to creating spaces that foster connection, creativity, and well-being.

Beyond individual projects, Cohort Three is also helping inform the future of LVCF's capacity-building work. Insights from fellows are shaping our approach as the Foundation explores ways to extend CORE's learning model to a broader audience of nonprofit leaders.

## A Long-Term Investment

The CORE Fellowship reflects LVCF's long-term commitment to strengthening the Lehigh Valley's nonprofit sector. By combining financial support with learning, coaching, organizational development, and peer connection, LVCF has helped leaders build the capacity to navigate change and strengthen their organizations. Looking ahead, the principles that shaped the CORE Fellowship continue to guide LVCF's work. By expanding access to capacity-building resources and sustaining strong leadership networks, the Foundation is helping nonprofit organizations meet today's challenges and lead the region into the future.

## Meeting Changing Needs

As the nonprofit landscape continues to evolve, LVCF has taken a thoughtful and proactive approach to its capacity-building strategy. While the CORE Fellowship has been highly impactful, the Foundation recognizes the importance of expanding access to leadership development opportunities and responding to changing conditions.

Building on the success of CORE, LVCF is broadening its approach to include expanded community grants for capacity-building, targeted workshops, and new learning opportunities inspired by the fellowship model. These efforts are designed to reach more organizations while maintaining the depth and quality that have defined CORE.

At the same time, LVCF remains committed to sustaining the relationships and networks that CORE has created. Alumni from all three cohorts continue to engage through cross-cohort gatherings and are shaping an alumni network that supports ongoing connection, collaboration, and shared learning.





## Putting Philanthropic Capital to Work for Community Impact

Impact investing is one way LVCF is expanding its philanthropic toolbox to address community needs. By mobilizing flexible capital, LVCF can advance critical projects that deliver clear community benefit. This approach allows donors to put resources to work in new ways that strengthen organizations, expand access, and support lasting impact across the Lehigh Valley.

In June 2025, LVCF took a significant step in impact investing by approving \$175,000 investment to Resurrected Community Development Corporation (RCDC). This investment supports the renovation of RCDC's church facility into a childcare center and affordable housing, creating new early learning slots for Allentown families.

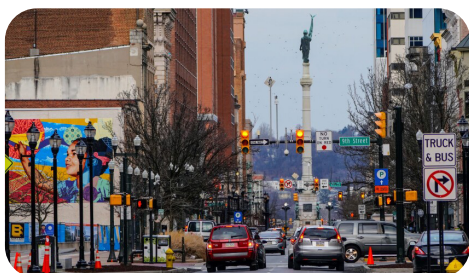
The funding stack behind this effort reflects exactly the kind of cross-sector problem-solving our region does best. Financing includes support from Finantand Truist, along with a \$3.4 million loan from the United Church of Christ's Church Building & Loan Fund, supplemented by federal, state, and city resources. LVCF is proud to provide a piece of the puzzle to move this long-awaited project from plan to groundbreaking.

### Leveraging Philanthropic Capital

The project represents a new model for leveraging philanthropic capital to drive community outcomes, expanding both the availability and accessibility of early childhood education in the region. LVCF's leadership in this effort was publicly recognized during a press conference celebrating the start of construction, where the Foundation was acknowledged as a key investor and strategic partner. ## Impact Investing: Putting Capital to Work Locally

At the Community Foundation, impact investing is about using all the resources at our disposal to do more for our community—beyond traditional grantmaking alone. While grants remain a vital tool, grant dollars are finite and do not return once they are distributed. As a community foundation, LVCF also exists to grow philanthropy by investing charitable assets. Impact investing allows us to intentionally connect these two roles and expand how philanthropic capital can serve the Lehigh Valley.



Through impact investing, LVCF seeks opportunities to move some capital from Wall Street to Main Street, investing locally in ways that generate both a financial return and meaningful social benefit. These investments are designed to align with our mission and values while supporting community priorities, including early childhood care

and other systems critical to long-term community well-being. By keeping capital closer to home, LVCF can help strengthen local institutions and support solutions rooted in community needs.

Impact investing differs from both traditional grantmaking and traditional investing in important ways. Grants support charitable work with no expectation of repayment, while traditional investing focuses primarily on financial return, often through global markets. Impact investing blends these approaches by deploying capital locally with the goal of achieving a social return alongside at least some financial return. This approach allows LVCF to be more intentional about where charitable dollars are placed and how they reflect community values.

LVCF's exploration of impact investing has been thoughtful and deliberate. While this approach has gained momentum across the community foundation field nationally, LVCF took time to build internal understanding, engage stakeholders, and ensure appropriate governance and oversight. Donor interest in locally focused philanthropy, combined with pressing community needs, reinforced the importance of advancing this work responsibly.

To deepen its capacity, LVCF staff participated in a Pennsylvania Association of Community Foundations (PACFA) impact investing learning cohort last spring. Through this experience, staff built relationships with peer foundations across the state and gained insight into the broader ecosystem that supports impact investing. The cohort concluded with an organizational plan that established two parallel paths forward: one focused on engaging fundholders through an impact investing circle, and another aligned with LVCF's internal community priorities.

Today, LVCF is in the early stages of this work—making initial investments, engaging fundholders, and inviting conversation about what impact investing can look like in the Lehigh Valley. This work continues to evolve, and LVCF remains committed to moving forward transparently, responsibly, and in partnership with the community.

### What Is Impact Investing?

Impact investing is an approach that uses philanthropic capital to generate both financial return and positive community impact. Unlike traditional grants, which are spent once, impact investments may be repaid and redeployed over time, allowing charitable resources to work longer and more strategically. Unlike conventional investing, which prioritizes financial performance alone, impact investing intentionally aligns capital with social values and community priorities.

Impact investing means putting dollars to work locally—supporting initiatives that strengthen critical systems, expand access to opportunity, and contribute to long-term community well-being. By blending mission and investment, impact investing expands the philanthropic toolbox and creates new pathways for donors and institutions to advance lasting, place-based impact across the Lehigh Valley.

Deeply engaged in community service, Baum has served on a range of regional boards, including the Greater Lehigh Valley Chamber of Commerce, Valley Youth House, United Way of the Greater Lehigh Valley, the Lehigh-Northampton Airport Authority, and Northampton Community College Foundation (chair). She joined LVCF's Board of Governors in July of 2025 and serves on the Community Investments Committee.

## A Community Conversation on Child Care in the Lehigh Valley

In September 2024, more than 135 community leaders, business executives, parents, providers, and elected officials gathered at Homewood Suites in Center Valley to confront one of the most urgent challenges facing the Lehigh Valley: access to affordable, high-quality child care. The breakfast convening was co-hosted by the Greater Lehigh Valley Chamber of Commerce, the Lehigh Valley Community Foundation (LVCF), and the Early Childhood Education Action Committee, reflecting the shared recognition that childcare is both a family issue and a workforce imperative.

The program opened with welcome remarks from **Linda Sheftel**, Chair of LVCF's Board of Associates, who emphasized the importance of collaboration in addressing complex community challenges. **Erika Riddle Petrozelli, CPA, CAP®**, President and CEO of LVCF, spoke, underscoring the Foundation's long-standing commitment to early childhood care and education as a cornerstone of economic mobility, family stability,

and long-term community health. The business community also weighed in. **Peter Danchak**, PNC Regional President, reaffirmed PNC's long-term commitment to early childhood education, emphasizing its connection to workforce readiness and economic competitiveness.

Moderated by **Tony Iannelli**, President and CEO of the Greater Lehigh Valley Chamber of Commerce, the panel explored how child care access—or the lack of it—affects families, employers, and the regional economy. **Megan Barnes Briggs**, LVCF Vice President of Community Investments, framed the issue as a systems challenge, noting that sustainable solutions must support

children's development while also enabling parents, particularly mothers, to fully participate in the workforce. She highlighted LVCF's role in convening partners and advancing strategies that address both immediate needs and long-term structural gaps.

From the provider perspective, **Charles Dinofrio**, President and CEO of Lehigh Valley Children's Centers, described a sector under strain. He outlined how rising costs, staffing shortages, low wages, and fragmented funding streams are squeezing both families and providers, making it increasingly difficult to maintain quality and stability across the system.

The discussion was grounded by lived experience. **Melinda Saunders-Wood**, a registered nurse and mother of three, shared the challenges her family faced navigating waitlists, affordability, and quality when seeking care. Her story illustrated how even families with steady employment can struggle to find reliable child care, underscoring the real-world consequences behind workforce and economic data.

Public-sector leaders reinforced the need for sustained policy action. **Congresswoman Susan Wild** spoke to the long-standing nature of the child care crisis and its implications for workforce participation and economic growth. **State Representative Peter Schweyer** emphasized the importance of legislative solutions, including universal preschool, better compensation for child care workers, and long-term funding models that allow providers to plan and grow. Allentown Mayor **Matt Tuerk** highlighted the local economic stakes, noting that child care access directly affects a city's ability to attract and retain workers and families.

**Rev. Dr. Gregory James Edwards**, President and CEO of Resurrected Community Development Corporation, called for reducing bureaucratic barriers and expanding culturally responsive, community-based child care solutions that meet families where they are.

Throughout the event, the Community Foundation's leadership as a convener was evident—bringing together voices across sectors to elevate the issue, share data and experience, and explore pathways forward. Convenings like this reflect the Foundation's broader impact strategy: strengthening systems, fostering collaboration, and helping align public, private, and philanthropic resources to support families and economic participation across the Lehigh Valley.

## Board of Associates Meetings



### Bridging Philanthropy & Finance:

## A New Era for Community Investment

On May 12, 2025, the Lehigh Valley Community Foundation's Board of Associates convened local leaders, fundholders, and community changemakers for an afternoon program exploring how philanthropy and finance can work together to address the region's most pressing challenges. Titled Bridging Philanthropy & Finance: A New Era for Community Investment, the event—sponsored by PNC—reflected LVCF's growing leadership in advancing innovative, place-based approaches to community investment.

The gathering opened with welcoming remarks from **Linda Sheftel**, Chair of the Board of Associates Executive Committee, who emphasized the importance of bringing people together across sectors to learn, question, and imagine new possibilities for impact. **Terrence A. McMahon** of PNC Institutional Asset Management followed, reinforcing PNC's commitment to community-focused investment

strategies and partnerships that strengthen local economies. **Erika Riddle Petrozelli, CPA, CAP®**, President and CEO of LVCF, then shared updates on the Foundation's strategic priorities, highlighting LVCF's role in aligning philanthropic resources with community needs and long-term systems change.

The keynote address was delivered by **Dr. Stephanie Gripne**, Founder and CEO of the Impact Finance Center, whose presentation challenged attendees to rethink how capital can be mobilized for social good. Drawing on national case studies and regional data, Dr. Gripne demonstrated that the Lehigh Valley already has the financial capacity to address significant challenges—if capital is activated differently. She shared a striking example: mobilizing just 0.2% of the region's estimated \$295 billion in private wealth could finance the development of approximately 9,000 housing units, meeting a critical regional need. With traditional banks able to

finance roughly 80% of such projects, only a fraction of local philanthropic and private capital would be required to catalyze change.

Central to Dr. Gripne's message was the concept of Full Spectrum Capital—an approach that encourages communities to deploy a range of tools, from grants and recoverable investments to loans, guarantees, and market-rate equity.





Rather than viewing philanthropy and investment as separate silos, Full Spectrum Capital invites foundations, donor-advised funds, and individuals to align “treasure,” “time,” and “talent” in ways that multiply impact.

Dr. Gripne also introduced the Philanthropic Opportunity Scan, a practical tool designed to help foundations uncover investment-ready opportunities within their existing grantee networks. She shared examples from across the country, including a case study from Essex County Community Foundation, where a scan identified more than 100 potential impact investments that had previously gone unrecognized. These examples illustrated how community foundations can uncover hidden opportunities by asking the right questions and pairing capital with technical assistance.

Interactive elements throughout the presentation—including role-play exercises and facilitated discussions—encouraged attendees to engage directly with these ideas. Participants were invited to reflect on how modest reallocations of assets, combined with strategic intent, could help build what Dr. Gripne described as a “caring economy”—one that values both financial return and human well-being.

The program concluded with a networking reception, where conversations continued about how these concepts could take root locally. As LVCF looks ahead, the 2025 spring gathering served as a catalyst—reinforcing the Foundation’s commitment to innovation, education, and leadership at the intersection of philanthropy and finance, right here in the Lehigh Valley.

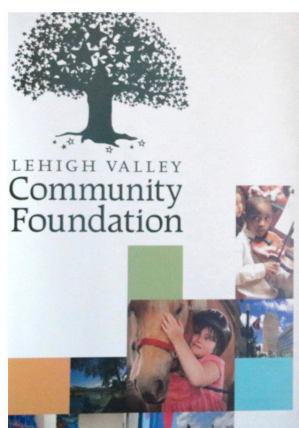
## Why This Matters

LVCF Co-Hosts with Estate Planning Council

## Program Focused on Family Business Succession

LVCF and the Estate Planning Council of the Lehigh Valley co-hosted a program that featured **Tom Garrity**, Managing Partner at Compass Point Consulting, LLC, who shared his expertise during his presentation, "Beyond Taxes—The Challenges of Succession Planning for Family Businesses and the Impact on Estate Planning." Tom provided valuable, real-world strategies to help families, business owners, and advisors navigate growth, ownership transitions, and long-term succession while preserving both enterprise value and family relationships.

The program began with welcoming remarks from **Erika Riddle Petrozelli, CPA, CAP®**, President and CEO of LVCF, who offered a brief overview of LVCF's mission and shared a compelling story of philanthropy that highlighted the lasting impact of thoughtful planning. Erika then introduced Tom, setting the stage for a meaningful discussion on how succession planning extends well beyond tax considerations to include governance, leadership development, and communication across generations.

Throughout the program, attendees engaged in thoughtful conversation around the complex challenges family-owned businesses face as they plan for the future. The discussion emphasized the importance of proactive, holistic planning that aligns business objectives with estate and legacy goals, reinforcing the critical role advisors play in guiding families through these transitions.





### LVCF Convenes Regional Leaders

## Addressing Early Childhood Education Challenges

In November 2024, the Lehigh Valley Community Foundation played a central role in convening regional leaders for a timely community forum focused on the state of early childhood education in the post-pandemic era. Hosted at the Univest Public Media Center in Bethlehem, the roundtable brought together nearly 40 early childhood education professionals to discuss workforce shortages, classroom challenges, and the growing social-emotional needs of young children.

The event was co-hosted by LVCF alongside PBS39, Lakeshore, and the Early Childhood Education Action Committee, reflecting a shared commitment to advancing dialogue and collaboration in a sector facing increasing strain. The conversation featured educators and nonprofit leaders from across the Lehigh Valley, including representatives from Community Services for Children, Pinebrook Family Answers, and Lehigh Valley Children's Centers, who shared firsthand perspectives on how early learning environments have grown more complex since the COVID-19 pandemic.

The discussion was moderated by LVCF's **Megan Barnes Briggs**, whose facilitation helped guide a thoughtful and solutions-oriented exchange among panelists. Through her leadership, the forum balanced candid discussion of challenges—such as behavioral needs, staffing shortages, and

program sustainability—with practical strategies to support educators, children, and families. Panelists emphasized the importance of classroom design, teacher support, professional development, and strong family engagement in helping young learners succeed.

The forum also featured **Coy Bowles**, a member of the Zac Brown Band and a children's book author, who reinforced the importance of social-emotional learning and creativity in early education. Bowles shared his experiences creating music and books for children and offered encouragement to educators, underscoring the collective impact of continued advocacy and collaboration.

LVCF continues to serve as a trusted convener and resource for nonprofit leaders, creating space for dialogue, professional development, and connection. By investing in the financial literacy and storytelling capacity of local organizations, the Community Foundation helps ensure that nonprofits across the Lehigh Valley are better positioned to sustain their missions and amplify their impact.

### Coffee & Conversation: Financial Storytelling in Uncertain Times

In February, the Lehigh Valley Community Foundation (LVCF) convened nearly 100 nonprofit leaders from across the region for Coffee & Conversation: Financial Storytelling in Uncertain Times, a capacity-building workshop designed to help organizations strengthen how they communicate financial need, impact, and sustainability. The program was held on February 24th at Northampton Community College's Fowler Center and reflected LVCF's ongoing commitment to equipping nonprofit leaders with practical tools to navigate an increasingly complex funding environment.

The workshop was led by **Tisha Hyter, CSRIC®**, Senior Vice President and Director of Nonprofit Strategy & Solutions at PNC Institutional Asset Management, who guided participants through a structured framework for financial storytelling. Drawing on real-world nonprofit scenarios, she emphasized how organizations can clearly articulate their challenges, describe their approach, demonstrate a track record of effective management,

and connect financial data to mission impact in ways that resonate with funders and stakeholders.

Tisha's presentation highlighted actionable strategies around diversification, endowment development, alliances, and long-term financial planning—critical considerations for nonprofits operating amid economic uncertainty.

The program opened with welcoming remarks from **Erika Riddle Petrozelli, CPA, CAP®,** President and CEO of LVCF, who underscored the Foundation's role in supporting nonprofit resilience and fostering shared learning across the sector. **Terrence A. McMahon, CIMA®,** Senior Investment Advisor at PNC Institutional Asset Management, introduced the presenter, reinforcing the collaborative partnership between LVCF and PNC to bring expert insights to the local nonprofit community. The event concluded with reflections from **Robyn Weaver**, LVCF Program Officer for Capacity Building, who encouraged participants to apply the concepts discussed to strengthen their organizations' financial narratives and strategic planning.



LVCF collaborated with LINC, United Way of the Greater Lehigh Valley, and the Volunteer Center of the Lehigh Valley to present Growing Together: Volunteer Power, Staff Well-Being, and Community Connection on April 28, 2025, at NCC. This milestone underscores our role as a trusted philanthropic partner and a permanent community resource. The \$100 million mark represents expanded capacity to respond to emerging challenges, deepen investments in local nonprofits, and steward charitable legacies for generations to come.

### A Milestone Built on Stewardship and Trust

On June 4, 2025, the Community Foundation marked a defining moment in its history—surpassing \$100 million in assets under stewardship. To honor this achievement, the Foundation welcomed past Board Chairs and Executive Directors to an elegant evening at Saucon Valley Country Club, bringing together leaders whose vision and commitment helped shape LVCF into the institution it is today.

“Reaching \$100 million is more than a financial benchmark. It reflects decades of careful stewardship, strong governance, and the enduring trust of donors who believe in the Foundation’s mission to strengthen the Lehigh Valley,” said **Erika Riddle Petrozelli**, President and CEO. “These assets—built through a combination of market performance and sustained ‘organic’ growth from new charitable funds—serve a single purpose: to generate lasting resources that support nonprofit organizations and address the region’s most pressing needs.”

The celebration was intentionally rooted in gratitude. Past leaders were recognized not only for their individual contributions, but for the collective leadership culture they fostered—one grounded in collaboration, accountability, and long-term thinking. Their guidance laid the foundation for LVCF’s continued growth, including the milestone of surpassing \$75 million in assets in March of 2021, and now reaching nine figures.

While the number itself is significant, its true meaning lies in impact—measured in stronger organizations, more resilient communities, and a region better positioned to thrive. The June gathering served as both a celebration of how far LVCF has come and a reminder of the responsibility that accompanies growth: to continue transforming generosity into meaningful, lasting change across the Lehigh Valley.







### Valley Youth House's Camp Fowler | A Walking Tour

The Community Foundation held an in-person walking tour of [Valley Youth House's Camp Fowler](#) in Orefield, offering fundholders and community partners a closer look at the organization's impact in action. Set across 43 wooded acres, Camp Fowler provides a welcoming environment where young people build confidence, leadership skills, and connections through experiential learning.

During the visit, participants explored the camp's facilities and learned about its diverse programming, including outdoor education, arts and STEM activities, ropes courses, swimming,

and archery. Camp leaders shared insights into how these experiences support youth development and foster resilience, teamwork, and personal growth. Attendees also received updates on future plans for the site, including the Carter Family Center, which will expand opportunities for year-round programming.

Through immersive nonprofit site visits like this, LVCF continues to connect its donors and fundholders with the organizations strengthening youth and families across the Lehigh Valley.



### Nonprofit Virtual Tours

In addition to the in-person nonprofit visit at Valley Youth House's Fowler Campus, LVCF invited fundholders, donors, and others to learn more about the needs of The Third Street Alliance (Easton) via Zoom in September 2024. We also conducted a virtual program to learn about the Early Childhood Education Collaborative and to launch the Week of the Young Child!

### LVCF Leads the Early Childhood Workgroup in Allentown's Recompete Grant Success

In 2024, the Lehigh Valley Community Foundation took a central leadership role in shaping a critical component of the City of Allentown's successful bid for the federal Recompete Pilot Program grant—a \$20 million U.S. Economic Development Administration award aimed at revitalizing some of the city's most economically distressed neighborhoods. The award was announced at a press event in August of 2024 (photos below). At the heart of this collaborative effort was a strategic focus on early childhood care and education, recognizing that access to quality childcare is a foundational enabler for workforce participation, family stability, and long-term community well-being.

LVCF's contribution to the Recompete application was led by **Megan Barnes Briggs**, Vice President of Community Investments, who convened a coalition of community partners, advocates,

and service providers to develop the early childhood section of the plan. This work was not an add-on—rather, it was integral to identifying barriers that prevent families from entering and maintaining gainful employment, such as the lack of affordable, accessible childcare options. By framing early childhood solutions as a central economic development strategy, the Foundation helped distinguish Allentown's proposal among a highly competitive field of over 565 submissions, ultimately securing one of only six national awards.

The childcare strategy crafted by LVCF and its partners emphasized enhancing childcare services to support both families and those working in the childcare sector. This dual focus aimed to strengthen the early childhood workforce, expand high-quality care availability, and create pathways for more residents to participate in the

broader economy. The importance of this approach was underscored by **Alejandra Y. Castillo**, U.S. Assistant Secretary of Commerce for Economic Development, who noted the often-underappreciated role of childcare in enabling parental employment.

Beyond the Recompete application itself, the Foundation's leadership in early childhood system building continued throughout 2024. LVCF serves as the backbone convener of the Early Childhood Education Collaborative, a regional coalition of nonprofits, policymakers, educators, and community leaders working toward systemic change in the early childhood sector. In this role, LVCF facilitates collaboration, aligns priorities, and mobilizes resources aimed at addressing long-standing challenges in childcare access, quality, workforce development, and affordability across the Lehigh Valley.

LVCF's early childhood work exemplifies how philanthropy can do more than just fund programs—it can shape solutions, build partnerships, and elevate community priorities. By extending this approach through its leadership on the Recompete grant, we are helping align early learning, family support, and workforce goals so that children and families can succeed.

**Learning and Leading** | A handful of LVCF staff attended the Pennsylvania Community Foundation Association's (PACFA) Third Annual Statewide Conference in State College during September 2024. 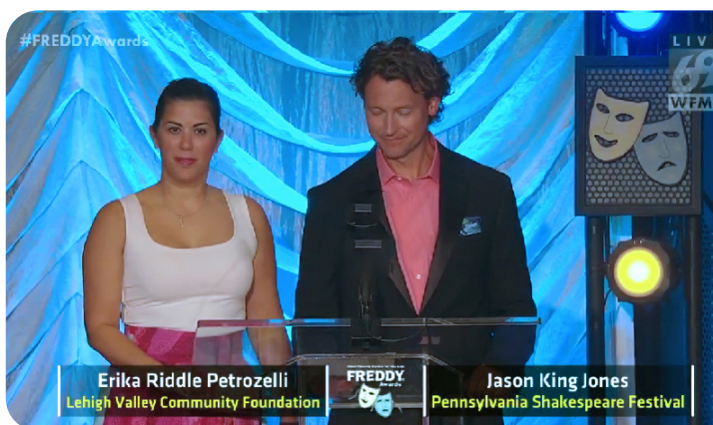

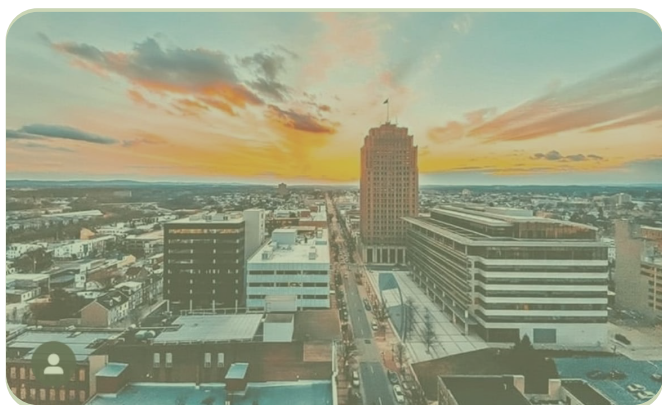

## Community Investments: Advancing Strategy, Strengthening Systems

In Fiscal Year 2025, the Lehigh Valley Community Foundation directed community investments toward the region's most pressing challenges while remaining responsive to emerging needs. Through a combination of strategic grantmaking, leadership, convening, and innovative tools, LVCF supported hundreds of nonprofit partners and strengthened the systems that underpin long-term community well-being. Below is an expansion on the main focus areas:



### Capacity Building & Leadership

LVCF continued its long-term commitment to strengthening nonprofit leadership and organizational resilience across the Lehigh Valley. Investments supported leadership development, governance and board effectiveness, strategic planning, and cross-sector collaboration. Through initiatives such as the CORE Fellowship and related capacity-building efforts, organizations gained tools to navigate workforce pressures, funding uncertainty, and increasing community demand—positioning leaders and institutions to adapt, stabilize, and lead through change.



### Early Childhood Education

Building on several years of intentional focus, LVCF prioritized early childhood education and care as a cornerstone of economic mobility, workforce participation, and long-term community health. Funding supported direct early learning services, childcare workforce development, and systems-level coordination among providers, funders, and public partners. These investments reflect LVCF's role not only as a grantmaker, but as a convener advancing shared strategies to expand access to quality, affordable care across the Lehigh Valley.



### Arts, Culture & the Creative Economy

Through state and local partnerships, LVCF invested in artists, cultural organizations, and creative entrepreneurs throughout the region. Grantmaking supported recovery from pandemic-era disruptions, strengthened organizational stability, and helped sustain the creative workforce. These investments recognize the arts and creative sector as both a cultural asset and an economic driver—contributing to community identity, vibrancy, and local economic resilience.



### Support & Donor-Directed Grantmaking

In addition to foundation-directed priorities, donor-directed funds continued to address a wide range of community needs. Through donor-advised, designated, scholarship, and area-of-interest funds, LVCF supported initiatives spanning education, human services, health, the environment, and neighborhood-based work. This flexible grantmaking reflects the diverse philanthropic interests of LVCF's fundholders while complementing the Foundation's broader community leadership goals.



## Select Grantmaking Highlights: FY25

In Fiscal Year 2025, LVCF's foundation-directed and donor-directed grantmaking supported a wide range of organizations and initiatives across the Lehigh Valley and beyond. The highlights below offer a snapshot of key grant programs and investments from the year—illustrating how resources were deployed to address immediate needs, strengthen organizational capacity, and advance long-term community priorities.

### Capacity Building & Leadership

Investments in capacity building and leadership focused on strengthening nonprofit leadership, governance, and organizational effectiveness. Additional funding and partnerships supported sector-wide workshops, learning opportunities, and leadership convenings addressing board development, volunteer engagement, and organizational sustainability.

- Nearly \$145,000 in foundation-directed grants supported organizations participating in the CORE Fellowship across three cohorts, funding organization-level capacity-building projects.
- When combined with investments in coaching, consulting, evaluation, and cohort learning, total capacity-building related program expenses exceeded \$300,000 in FY25.

### Early Childhood Education & Care

LVCF directed significant funding toward stabilizing and expanding early childhood education and care across the Lehigh Valley. Grants focused on workforce stabilization, program quality, facility improvements, and expanding access to care. In addition to direct grantmaking, LVCF invested staff capacity and leadership support as the backbone convener of the Early Childhood Education Collaborative, aligning funders, providers, and public partners around shared strategies.

- More than \$325,000 was awarded through the Early Childhood Care Fund across multiple grant cycles, supporting childcare providers, early learning programs, and family-serving organizations.

### Arts, Culture & the Creative Economy

LVCF administers the Creative Sector Flex Fund and the Creative Entrepreneurship Accelerator Program which is made possible by The Pennsylvania Creative Industries, powered by the Pennsylvania Council on the Arts (PCA), and the Pennsylvania Partners in the Arts (PPA) regional funding partnership. State funding is provided by Pennsylvania's General Assembly and the National Endowment for the Arts, a federal agency.

- More than \$123,000 was awarded through the Creative Sector Flex Fund and the Creative Entrepreneurship Accelerator Program to arts and culture organizations and individuals across Carbon, Lehigh, Monroe, and Northampton counties, supporting operating stability and creative recovery.

### Scholarships and Donor-Directed Awards

Through donor-directed scholarship and award funds, LVCF continued to invest in education and opportunity across the region. These grants supported students and individuals pursuing a wide range of educational and career pathways, reflecting the diverse philanthropic interests of LVCF's fundholders while complementing the Foundation's broader community investment priorities.

New in 2024-25, **The Good Neighbor Fund** supported households facing rising energy costs by providing grants to nonprofit organizations with existing utility assistance programs. In its 2024–25 cycle, LVCF awarded \$195,000 across 14 community-based partners serving 29 counties in eastern and central Pennsylvania.

These organizations delivered financial support for home energy needs—such as electricity, fuel, oil, and wood pellets—for households earning up to 300% of the federal poverty level, with assistance capped at \$1,000 per household.

Made possible in partnership with the PPL Foundation, the Good Neighbor Fund strengthens the capacity of local nonprofits to help neighbors keep the lights on and stay warm. [More...](#)
